**Background**

The Greater El Paso CCIM Chapter honors and supports the new Minor in Commercial Real Estate at the University of Texas at El Paso (UTEP), and in doing so created the Carleen R. Barth CCIM Scholarship.

**About the Greater El Paso Chapter**

The Greater El Paso CCIM Chapter is a 501(c)(6) non-profit organization, and is the local liaison and host for the Certified Commercial Investment Member (CCIM), National Institute. The Greater El Paso CCIM Chapter provides networking, education and technology opportunities to local commercial real estate individuals and entities.

**Scholarship Program Guidelines**

The Carleen R. Barth CCIM Scholarship was created to support UTEP College of Business majors in their efforts to pursue the Minor in Commercial Real Estate. Recipient should exemplify the highest caliber of student, and an intent to enter the commercial real estate industry is preferred but not required. Applicants should have an interest in participating in and/or volunteering for the various Greater El Paso CCIM Chapter annual activities via committee involvement.

**Scholarship Selection Criteria**

Includes the following:

- Each applicant should be able to demonstrate a commitment to entering the business industry; a desire to enter the commercial real estate industry is preferred but not required (demonstrate in essay questions below).
- Applicants must have a minimum cumulative GPA of 3.00, must be a declared major with the UTEP College of Business Administration (COBA), and must declare the Commercial Real Estate (CRE) minor with UTEP COBA.
- Successful Completion of the course with a C grade (2.00) will be required of the recipient. The recipient acknowledges that failure to produce a C grade (2.00) or better will be at risk for having the scholarship funds rescinded.

**Scholarship Value**

Recipient will receive **\$1,000** to offset the cost of a **course in the UTEP COBA Minor in Commercial Real Estate**.
