Mutual Aid Economics

A sufficient approach to economics and economic development must accomplish two things: (1) explain not just the market economy and monopoly capitalism but also material life (Braudel's "lowest stratum of the non-economy, the soil into which capitalism thrusts its roots but which it can never really penetrate"); and (2) have at its center a theory of value that is based on how people choose to exert their energies, whether inside or outside of the market. While "development" has increased material productivity in the market and especially the "antimarket," it has generally done so at the cost of development of material life and the production of community. Beginning with an account of development of material life in pre-capitalist societies, including the value placed on collective joy, this book then examines development of capitalism and monopoly capitalism but always with an emphasis on the ways that innovation and capitalist development impact on material life. Subjects include conflicts between institutions and practices of mutual aid and possessive individualism; the working day, the nonworking day, and the rise of 24/7 capitalism; interactions between market society and household/community societies; forms of subsistence/provisioning; innovation, technology and deskilling; organization of work, organization of material life.
