INSTRUCTOR'S INTRODUCTION: Hector Romero received his BFA in painting and drawing from UTEP and his MFA from UCLA. After living in NYC for 15 years as an art book seller and working artist, Hector returned to El Paso in 2011.

COURSE DESCRIPTION: Painting 1 is a course focused on the basics of painting. The course will cover palette set up, canvas preparation, stretcher building, under painting, mixing color, and the completion of a painting. Painting from observation and rendering what you see in paint is an important aspect of the course. Drawing, composition, contrast, color, and the surface of the painting are tools and methods used in this course. Do not think in terms of perfection, mistakes and trial and error are part of the process of painting. The beginning of the course will start with specific assignments with more freedom towards the end of the semester, allowing you to make paintings based on your ideas.

COURSE PRE-REQUISITE INFORMATION: The prerequisite for Painting 1 is Basic Drawing 1, 2 Basic Design 1,2 or instructor approval.

COURSE GOALS AND OBJECTIVES:

- Paintings to be worked on during class. Direction of the assignments may change as needed. Expect to work 3 to 4 hours outside of class
- Experience the handling of paint
- Address composition
- Exposure to painting both historical and contemporary
- Further develop one's ability critically discuss art works
- Development of personal ideas and imagery
- A strong work ethic

COURSE REQUIREMENTS:

Student work will be reviewed throughout the course of the semester, meaning I will be following the progress of your work. The completion of all painting assignments is the goal you should be focused on as this will contribute to the development of your ideas, artistic vision, and success. A high level of artistic work ethic is expected for this course. A lack of work ethics will be easy to note and result in a low grade. Readings and other instructional media may be provided to the class and allow for discussions as a group or one-to-one. Participation, discussion, and attendance to critiques are required. In certain cases, specific assignments may be given to students in order address issues or concepts on an as-needed basis. Please note that at the beginning of the semester students will be given specific painting assignments that will serve as an introduction to course and require completion. **FINAL CRITIQUE FOR THIS COURSE IS TUESDAY, DEC. 9th, 10:00 AM – 12:45 PM**

COURSE POLICIES:

Regular attendance is required. Roll will be taken every day. Arrive to class on time with the materials needed for class and stay until the end of class.

After 3 absences your final grade will be lowered by 5 points for every additional absence. Absences may be excused with official documentation for serious illness, death in the immediate family, or university sanctioned events. Arriving to class late or leaving early counts as ½ absence. Students with excessive absences and tardiness should consider dropping this course and taking at a time when the student can commit to the course.

Critiques are equivalent to an exam. Late arrivals to critiques may not be critiqued, this will be at the discretion of the instructor. No show to critique on the day you are presenting will receive a grade of F/0. No show to the day you are in the audience will receive a grade of D/65.

Turn off your cell phone when in class. Texting and using cell phone in class will reflect in your grade. If it is an emergency, deal with it and communicate with the instructor.

Please keep the studio clean by cleaning up after yourself at the end of each class session.

Incompletes, Withdrawals, Pass/Fail: Incompletes or “I” grades will be considered for students completing satisfactory or better work and having serious legitimate situations beyond their control requiring additional time to complete the course requirements. All “I” grades are at the discretion of the instructor and the approval

of the Dept. chair. Students hold full responsibility for withdrawing from this course if that procedure is elected. Withdrawals must be completed on or before the final date to drop a course with a W. Student initiated drops are permitted after deadline and in this case instructor will issue a grade of W or F.

This is a grade-based course and is not available for pass/fail options.

MATERIALS AND PERSONAL EQUIPMENT: each student must have his or her own materials. Borrowing from other students is unacceptable.

- Oil Paint, some will be supplied but you may supplement by purchasing your own colors as well
- White, Alizarin, Cad Red hue, Cad Yellow hue, Ultramarine Blue, Pthalo Blue, Pthalo Green, Burnt Sienna, Dioxazine Purple, Paynes Grey, Yellow Ochre
- Set of 7 Pro-stroke bristle brushes
- Palette knife, containers, jars, paint rags
- Lava soap for brush cleaning
- Spray bottle
- Color wheel
- Masking or Blue painter's tape
- **You will need to purchase a stretcher bar for your final painting, two choices 24x30" or 22x28" your choice. Details will be discussed.**

*Please note paint runs out and you may have to purchase more as the semester progresses.

Health and Safety: Students will be working with oil paint, OMS, paint medium. No food or drinks are allowed in the studio place these items on the cart outside of the studio. Never pour OMS or gesso down the sink. Cleaning procedures will be explained at the beginning of the semester. Nitrile gloves are recommended for the course best place to purchase is Harbor Freight.

Supplies are available at Michael's, Hobby Lobby. And Art Center (on Yandell). Online you may order from Blick Art. Additional supplies may be needed. Students should sign up for a locker in the Art Office, room 350 Fox Fine Arts.

CRITIQUE:

Formal and informal critiques will be held during the semester. Students are expected to participate fully in class critiques both by offering constructive commentary to their peers and by later considering and applying what has been discussed to one's own work. When you examine and critique your work or the work of others, evaluate not just the aesthetic sensibility or the artistic achievement of the work. Evaluate also:

- The focus of the work
- What you think is being communicated
- The points of struggle in the work, what's working what's not working
- How problems can be resolved

CRITIQUE ETIQUETTE:

- Don't miss critiques !
- Arrive on time to set up work
- If you arrive late do not interrupt class by setting up your work. Work may or may not be reviewed, this will be at the discretion of the instructor
- Listen carefully to comments about your work
- Listen to comments about the work of your peers (it probably applies to you too)
- Contribute to the discussion
- Don't disrupt the critique with private conversations or cell phone use
