Instructor's Introduction

Tom Birkner is a painter with a BA from Rutgers University and an MFA from The Pennsylvania State University. Before coming to UTEP, he taught at Drew University, Madison, NJ and at Parsons The New School for Design in NY and Paris. Tom's work is widely exhibited and he is represented by Paul Thiebaud Gallery, San Francisco, and Gerald Peters Contemporary, Santa Fe.

Course Description

Painting on canvas is a unique format in art history. It is specific to Western art and has set the stage for the remarkable feats of representation that has defined what art is for over 1000 years. But from the earliest cave paintings to Egyptian tombs, from Neapolitan villas to the great cathedrals of Europe, from royal palaces to street murals, painting has never been limited to canvases and white gallery walls.

This class will be devoted to painting beyond two dimensions. Different strategies will be considered: built-up and layered surfaces, integrated frames, painting on objects, altering/adapting the walls paintings are hung on, transforming the space paintings are installed in, paintings levitating in space, and paintings as part of sculptural forms.

Attention will be paid to using materials, designs, and layouts that enhance the look and meaning of your painted imagery. Existing work can be embellished or new work can be created specifically for the class. Either way, one can expect new perspectives on content to open up as we work through new possibilities of presentation.

This will be a highly improvisational class. Things will absolutely change depending on your interests, weather, logistics, etc. Be ready to accept this as part of leaving the comforts of the studio and embracing life. To serve as an example and also make sure there's a logical weekly flow, I will work on my own series right along with you.

Expect to work 4-5 hours per week outside of class time to meet basic requirements.

PNTG on Blackboard

There will be weekly reading on Blackboard. Writings on art and installation from by Claire Bishop, Jaques Derrida, and Klaus Kertess, among others, will be coupled with a look at work by people like Lynn Foulkes, Ilya Kabakov, Annette Messager, Matthew Ritchie, and Sarah Sze.

Course Material Is Subject To Change

As mentioned, the syllabus is a guideline. Changes will occur based on class interests and needs. All changes will be attempts to make the class better.

Course Requirements

- 1. A brief, written outline of possible approaches to 3D painting and/or installation.**
- 2. A coherent series and/or installation that can occupy a 250 square foot space.**
- 3. An exhibition at Alameda Art + Salvage.**
- 4. Written statement (3 paragraph minimum) on your series due final week of classes.**

The artwork is, by far, the most important part of this course and will count for 90% of your grade. The writings will count for the rest. **However, at 10% of your grade, failure to do the writing component will result in a drop of a letter grade.**

IMPORTANT NOTE: Your total semester production should equate to at least 130 hours of work.

Class Critiques and Reviews

There will be two full-class critiques. One at Week 7, and the final critique in finals week.

Grading Guidelines

Grading will be based on cumulative effort, improvement and quality. Because skill levels vary, evaluation will be influenced by improvement on an individual basis. Here's a basic outline of grading priorities:

Attendance Policy

Attendance, punctuality, participation and appropriate class conduct are crucial. Failure to perform to required standards will result in strong grade penalties and can cause failure of this course.

- Each student is permitted 3 absences during the semester without penalty. Students with more than 3 absences should consider dropping this course and retaking it at a time when the student can commit the proper attention to the course.
- **Each unexcused absence after 3 will result in the final course grade being lowered by 1 full letter grade.** Absences after the first 3 can be excused only if the first 3 absences are excused.
- Excused absences are defined as documented illness or serious illness or death in the immediate family.
- Coming to class late or leaving early is unacceptable. All students are required to attend class on time and to remain in the class the entire time. Entering class late and leaving early is disruptive, disrespectful and sets an intolerable standard for everyone.

Course Participation:

- Participation in all discussions, critiques and class days is required for this course.
- Development and execution of class projects must be done utilizing all class meetings.
- Projects executed solely out of class will not be accepted.
- Participation in the collaborative group environment of the studio is essential to the successful completion of this course.

Class Conduct:

- Sick Policy - If you are not feeling well, or if you are sick, then you should not come to this class under any circumstances. You should instead seek medical care, and/or recuperate at home. Email me or call me when you are able and let me know the circumstances, and I will help you to catch up in class when you are feeling better. . If you are pregnant, or have other physical issues such as allergies to dust, respiratory issues, anything that I should be aware of, please inform me of this immediately, and we will work to make you safe and comfortable. If a family member is ill, and you need to care for that person, please email me or call and let me know what your situation is.
- Guests - Guests are not permitted at any time during class. You are expected to remain in class at all times, and may not step-out to visit with guests during class. There will be one warning. After that, you will be asked to leave class and you will be counted absent.

- Music - Ear phones are permitted in one ear, and not during class discussion.

- Studio Hours - The studios will be open only during scheduled class times until further notice.
- Studio Safety - Some aspects of painting can be hazardous if proper precautions are not taken. All safety procedures will be explained to you throughout the semester, and every consideration has been taken to create a safe environment for you to work in. If you are pregnant, or have other physical issues such as allergies to dust, respiratory issues, anything that I should be aware of, please inform me of this immediately, and we will work to make you safe and comfortable.
- Cleanliness - You are required to clean up your work area when you are finished working in the studio. Please put all of your tools, materials, etc. away in your lockers, and wipe down tables, easels and sinks. Do not leave paint or mineral spirits on the floor. Close all jars containing mineral spirits and put them in the flame-retardant cabinet in Studio A457 or A459. Put all rags with solvent on them on the red, flame-retardant trash cans with lids. If you have difficulty cleaning up after yourself, then you will receive a special tutorial on how to clean up after class.
- Work Removal - Finished works must be removed at the end of the semester. UTEP will not be responsible for work left in the studio. All materials, canvases, etc. will become the property of UTEP Painting after the clean-up deadline. Exceptions to this rule must be discussed with me.

Late Assignments, Make-up Work and Exams

Late and make-up work are only afforded in the case of an excused absence by arrangement and approval of the instructor.

Incompletes, Withdrawals, Pass/Fail

- Incompletes or "I" grades will be considered for students completing satisfactory or better work and having serious legitimate situations beyond their control requiring additional time to complete the course requirements. All "I" grades are at the discretion of the instructor and the approval of the Department Chair.
