Proposal Title:

Increase Repeat Limit of Required Course: CRIJ 4312 Criminal Procedure

Effective with the Fall 2016 catalog, the department added a new required course called *CRIJ 4312 Criminal Procedure*. Criminal Justice majors must earn a "C" or above in CRIJ 4312. This course was already approved by the UG curriculum committee.

When this course was created, the department mistakenly set the repeat limit to "1" in the original form. Thus, students who earned a "D" or "F" MUST re-take the class until they earn a "C" or above, but the second class was not correctly showing up on their CAAP degree evaluation. When the department asked Julie Rivera about how to remedy this, she said that we should increase the "repeat limit." By increasing the number of times a student can re-take the class to 3 (which is what the department should have initially done), the revised process will now be easier for students to be able to re-enroll without special permission.

Rationale for changing the course:

As of 2016, Criminal Justice majors must earn a "C" or above in this required course. Students who earn a "D" or "F" MUST re-take the class until they earn a "C" or above. By increasing the number of times a student can re-take the class, this process will be easier for students to be able to re-enroll without special permission.
