# V. Special Business

- Presentation by Dr. Julie Rivera, Director of Academic Reports & Curriculum, on "An Overview of Policy and Procedures"
  - o Curriculum and Administrative Unit Changes
    - www.utep.edu/provost/curriculum/index.html

- Topics have guidance on curriculum processes
- Useful for departments & programs to understand rules for curriculum changes and implementation
- Things To Consider:
  - Do the proposed changes fit within degree plan?
  - The documents that are required in most proposals include: a memo (in all proposals), proof of approval (in all proposals), tracked changes of an updated degree plan (in most proposals)
    - Course additions & deletions require tracked changes of a degree plan
  - Programs of Study must be included for Financial Aid calculations and changes must be part of the updated degree plan
  - All undergraduate degrees have 120 hour requirement
  - The addition/removal of prerequisites could add to the complexity of degree pathways or make it difficult for students to finish degree plans
  - Degree plans that include courses from multiple departments require approval from all departments involved
  - There are changes that do not require full curriculum approval:
    - Previous procedure involved full approval starting at the department and ending with the Faculty Senate
    - Current procedure now involves minimal approval that start with the department and end with the College
    - Example adding/removing courses in fast-track program only need college approval; changing course prerequisites or restrictions only need college approval if they are from the same department that is requesting them
  - Degree plan changes can only be made at the start of every fall term, prerequisite changes can be made at any term
- o Undergraduate Curriculum Changes Timeline
  - Total timeline around 7 months
    - College Curriculum Approval and Faculty Senate Undergraduate Curriculum Committee Approval – 2 months
    - Faculty Senate 2 months
    - Action Report with signature 2 or 3 months
    - Implementation 2 weeks
  - Most proposals are reviewed in Fall (in November or December)
  - The Course Catalog is published in April
    - Includes catalog and CAPP (degree evaluation) updates
  - Updates at the Texas Higher Education Coordinating Board (THECB)
    - Working on changing forms for new programs, not finalized yet
    - Trying to streamline forms, processing, and approval time so that timeline will be several months shorter
- Discussion during committee:

- Question from Heyman Would removing a pre-requisite require only program approval (in a situation where the only effect is on another course in the program)?
  - Answer No, approval comes from the Liberal Arts Curriculum Committee
- Question from Heckert When a proposal goes before the Undergraduate Curriculum Committee, who represents the proposal?
  - Answer Committee choice, but the person who develops the proposal should be the one to represent

      - Addition of three courses: ANTH/SOCI 3318 & ANTH/SOCI 3305
        are transitioning from "Special Topics" to regularly offered
        courses because of strong enrollment. ANTH/SOCI 2317 will be
        cross-listed with NAIS 2300 and can fulfill elective requirements
        for SOCI/ANTH majors and minors. ANTH 4343 course name will
        be changed to reduce confusion by students who think they
        need a medical background to enroll in course.
