Proposal Title: Prerequiste change for MUST 5317: Analytic Techniques

Explain the nature of the change and the rationale.

MUST 5317: Analytic Techniques is a course that is required of all MM candidates. All students take a placement exam to determine if they have deficiencies in music theory knowledge that is necessary for this course, as specified by accreditation guidelines. Currently, either a passing score on the placement exam or completing a theory review course, MUST 5313, with a grade of B or higher has been the prerequisite for this class.

Student performance on the placement exam varies widely. Many have deficiencies in a few areas of music theory (a general subject involving analytic skills that is taken by music majors of all specialties), though not so extensively that registration for a 3-credit review course is necessary for remediation. The Department of Music will develop review modules accessible via Blackboard that will serve as a means of remediating deficiencies in specific topics. Students' placement exam results will be assessed, and they will be required only to take modules corresponding to topics for which they displayed deficiencies. A passing score on these modules will demonstrate readiness for MUST 5317.

The Graduate Program Director will oversee the testing and remeditation process and enter approvals for MUST 5317 for students who have completed the requirements. Thus, the department seeks to change the prerequiste from its current form "Course or Test: MUST 5313 Minimum Grade of B May not be taken concurrently" to "Departmental Approval".

Rationale for changing the course:

The current prerequisite for MUST 5317 is either a passing score on a placement exam or completion of a theory review course, MUST 5313, with a grade of B. As student performance on the placement exam varies widely, the Department of Music has developed a system of remdediation via Blackboard modules that is better suited to address specific deficiencies. A change of prerequisite to "Departmental Approval" is sought, as the Graduate Program Director will oversee the testing and remedition process and enter approval for students who demonstrate the necessary skills for MUST 5317.
