Rationale

Our Spanish M.A. is at risk of being closed due to low enrollment. Our Bilingualism and Applied Linguistics M.A. has been more successful, but enrollment is not as high as it should be. Additionally, starting in January 2025, there will be only one tenured faculty member in Spanish left in the department (search underway for a tenure-track faculty member in Latino/Latin American Cultures and Digital Humanities), making it difficult for 1 (and subsequently 2) people to maintain a graduate program in Spanish.

We propose to consolidate our two M.A.'s into one (with two concentrations) to remedy these difficulties and ensure that our enrollment across the two programs is healthy. We are also making changes to the Spanish concentration to make it more practical and attractive to students. Most Spanish M.A. students that we have had are educators. We propose to shift the focus from Spanish Literature to Spanish Literacy and Culture. We are also making the choice of electives more flexible given the limited number of Spanish faculty that we (will) have in the department.

Because the required courses have changed a bit for the Bilingualism and Applied Linguistics concentration, we also need propose to update graduate certificate in Teaching ESOL so that it is in line with the new M.A.

Given the combination of the two M.A.s, we need to update the CIP code so that it is encompassing of both concentrations, and we need to update the admission requirements so that they are consistent between the two concentrations (but with some additional specifications for each concentration).

Note for Graduate Council: The core courses for the two concentrations are related to language learning and teaching, which is relevant for both concentrations. The Spanish M.A. currently doesn't have a thesis; given the small number of Spanish faculty, we are not adding a thesis requirement at this point. Importantly, we are adding an exam track for the Spanish Literacy and Culture concentration (for students who may not have the skills to do a research project), and we are leaving the set of electives open so that students have more options of relevant courses they can take that can count as electives. The proposed consolidated M.A. is much more flexible than the existing (Spanish) one, and it is much more practical and will likely be more appealing to students.

The University of Texas at El Paso requests approval to change the admission criteria for the M.A. in Languages and Linguistics (consolidation of M.A. in Bilingualism and Applied Linguistics and M.A. in Spanish) within the College of Liberal Arts and Department of Chicano Studies, Languages, and Linguistics as follows:

<u>Description of Change:</u> (List only the changes being proposed.) Example:

- Fulfillment of all general requirements for admission to Graduate School.
- Applicants from countries where English is not the first language are required to demonstrate English proficiency. Please consult the <u>graduate school</u> website for required scores.
- Three letters of recommendation.
- A brief (two- to three-page) personal statement of purpose.
- For students seeking admission into the Spanish literacy and culture concentration, at least an "advanced" proficiency in Spanish, as determined by the ACTFL Proficiency Placement Test.

Rationale for Change:

We need to make our admission requirements uniform given the consolidation of the two M.A. programs. Our undergraduate B.A. in Spanish also no longer requires the courses that are listed as prerequisites for the M.A. in Spanish, so this requirement was removed, and a Spanish proficiency requirement was added.
