This Stage II Randomized Efficacy Trial will compare the effectiveness of a theoretically informed and culturally responsive brief motivational intervention to a non-adapted brief intervention among non-treatment seeking Latinxs admitted for medical treatment of an injury who engage in at risk drinking or were drinking at the time of their injury. The culturally informed brief motivational intervention (CI-BMI) increases autonomous motivation to engage in protective drinking behavior and reduce alcohol problems while addressing barriers to help seeking and facilitating treatment utilization. This project will address the alcohol related health disparities and treatment inequities among Latinx who are more likely

to experience alcohol problems yet less likely to receive treatment in order to reduce the negative public health impact of alcohol.

Evidence that Latina women may be disproportionately affected by some alcohol-related health problems (e.g., brain damage) as compared to Latinos is growing, underscoring the public health significance of examining alcohol use among Latinas. The research proposed in this K01 application will first examine national data to assess patterns of alcohol use and misuse that are the most reflective of the current U.S. Latina population, and next use a sequential mixed methods approach to identify and assess salient and important drinking-related gender role expectations that are endorsed by Latina women. This project seeks to triangulate across distinct and complementary research methods to comprehensively address major gaps in the literature on alcohol use among U.S. Latinas, in an effort to benefit future prevention and treatment programs designed to reduce alcohol-related health disparities in an increasingly at-risk group.

Previous research, including that of our team, shows that a significant portion of those regularly using opioids—particularly filling opioids at community pharmacies—also are involved in the co-use of alcohol.
