EXPLANATION OF DEED OF GIFT

The enclosed Deed of Gift form is designed to legally assign to The University of Texas at El Paso a collection of personal papers or other materials which you as a Donor are placing here for care and administration. Besides expediting the transfer of title to the papers, the Deed of Gift form also serves to define the terms of transfer.

Donation of Gift. The "Name" and "Description" portions of this section will be completed by a Special Collection Department representative. The "Description" of the donation will state the type of material transferred.

Access Restrictions. Although most Donors will have no need to limit access to collections of personal papers which they possess (especially if the papers relate to activities occurring years ago) the option of placing restrictions on access to a collection or a portion of a collection is always available to a Donor. For example, a person who recently has been involved in an unsettled controversial issue may feel that portions of his/her papers concerning that issue are too sensitive to allow current access to them. He/she may specify "_____ records not to be copied or referenced in publications until January 1, 2015," or a similar provision.

Single Copies. The privilege of ordering facsimile (usually photocopied) copies is offered as a convenience to researchers, particularly to those who visit from great distances and whose time is limited. This practice is standard in the archival field. When copies are requested, researchers are informed that they may not quote for publication without permission.

Assignment of Copyright Rights. To enable scholars to quote readily from papers, we encourage Donors to transfer their copyright rights to The University of Texas at El Paso Library whenever possible. The precise contours of copyright protection, if any, relating to a specific work is a highly fact-specific inquiry that involves an analysis of the date a work is completed, any publication efforts and the location of publication, copyright registration and renewals. The lifetime of the author may also be relevant. In general, for writings created after Jan. 1, 1978, copyright protection extends for the life of the author plus 70 years. If the author's death date is unknown or if the author is unidentified, the writing may be protected by copyright for 120 years following its creation, though again all the facts relating to authorship, creation, publication and registration/renewals involving the work should be evaluated.

It should be noted that conveyance of copyright rights applies only to communications of the person who actually created the work. Copyright rights to writings of other individuals and organizations contained in the personal papers (usually incoming letters) remain with those individuals and organizations and cannot be transferred by the Donor; only physical property in these writings is transferred.

Assignment of copyright rights may be bounded by specific limitations. A Donor may wish to stipulate, "Copyright rights retained during my lifetime and thereafter assigned and transferred in full as described above" or something similar in the "Additional terms and conditions" section.

If the Donor desires to retain all copyright rights that he/she possesses, the section pertinent to the transfer of such rights may simply be crossed out and initialed.

Distribution and Disposition of Materials. In order to insure maximum use of a donation of personal papers and in order to best utilize library resources, the Special Collections Department reserves the right to distribute and dispose of materials contained in a collection as it deems most suitable. Examples of materials often judged to be inappropriate for care and attention by the Department are: books, periodicals, pamphlets, multiple copies, ephemera and the like. Materials such as books and serials are normally transferred to other Library units where they are given specialized care and attention. Multiple copies and various ephemeral materials can most often be disposed of without in any way impairing the value of a collection. If the Donor wishes any duplicate materials or materials not wanted by the Library returned, she/he should state this.

Acknowledgement of Receipt of Gift. This final section of the Deed of Gift serves to formally acknowledge the receipt of a donation of personal papers under the terms specified by the Donor. Formal acceptance of gifts of papers by the Special Collections Department serves to officially complete donation transactions.

Change in Provisions. If the Donor feels that any terms in the agreement should be deleted, he/she may line them out and initial the section in the margin. Before doing so, and especially before adding any new provisions, she/he is encouraged to discuss such terms with a Division representative to make sure they are workable.
