The initial application is to work with CRISPR-modified FKBP52-knockout human cancer cell lines alongside their wild-type parental controls. The goal is to analyze cell proliferation, survival, and potential drug responses, particularly those affecting AR pathways at BSL-2 containment level. The protocol was approved as is.
