Your application was selected for a process called verification. When reporting people in the family size section of the verification worksheet, you should only include individuals who receive more than 50% of their financial support from your contributor parent(s). **Do not report unborn children.**

Extended family members or other individuals (such as your adult siblings, nieces, nephews, etc.) may be included only if they live with your contributor parent(s) AND receive more than half their support from your contributor parent(s) during the school year. Extended family members should not be listed in the family size if they are:

- Working/employed/self-employed
- Receiving pensions/retirement
- Receiving means-tested benefits (SNAP, TANF, WIC, subsidized housing, etc.)
- Receive Social Security Income or Disability payments

To claim your parent(s) support an individual who is receiving any of the benefits listed above, their total financial support must exceed the amount those individuals receive from these sources. Please consider these sources of income carefully before claiming that your parent(s) support extended family members or other individuals more than 50%.

FAMILY SIZE

List the people in your contributor parent's household. Include:

- Yourself (the student),
- The student's parent (and their spouse), even if the student is not living with them because of college enrollment. Exclude a parent who is not living in the household because of separation or divorce.
- The student's siblings if the following are true:
 - They live with the student's parent(s) (or live apart because of college enrollment),
 - They receive more than half of their financial support from the student's parent(s), and
 - They will continue to receive more than half of their support from the student's parent(s).
- Other persons if the following are true:
 - They live in the same home as the student's parent(s),
 - They receive more than half of their financial support from the student's parent(s), and
 - They will continue to receive more than half of their financial support from the student's parent(s) between July 1, 2025 and June 30, 2026.

- THE PARENT SHOULD NOT INCLUDE ANY UNBORN CHILDREN IN THE FAMILY SIZE.
