Permit Agreement

I agree to assume full responsibility for any violation involving either my vehicle(s) or my permits(s) regardless of who actually drives and parks the vehicle on campus. The UTEP Parking website contains the official text of the UTEP's parking regulations. I understand that I may request a paperback copy of these rules and regulations at the Parking and Transportation Services (PTS) Office but otherwise acknowledge that electronic copies and updates may be posted on the PTS Office website. I understand that it is my responsibility to read the University's Parking & Transportation Rules and Regulations and understand that failure to do so may be the basis for further disciplinary action by the University. I understand that the University of Texas at El Paso is in no way responsible for damage or theft to my vehicle while parked on University property.

I agree to notify the PTS Office within 5 days of any changes that affect my parking eligibility or changes to my vehicle record. Failure to do so may result in the issuance of citations. Additionally, I will return the permit to the PTS Office if my status changes or I will forfeit my \$200 deposit.

- **PARKING PERMITS WILL NOT BE MAILED OUT BEFORE AUGUST 1ST OF EACH ACADEMIC SCHOOL YEAR.**
- **PARKING PERMITS MUST BE PROPERLY DISPLAYED AND VISIBLE TO BE VALID.**
- **ALL PARKING PERMITS ARE PROPERTY OF THE UNIVERSITY OF TEXAS AT EL PASO AND ARE NON-TRANSFERRABLE.**
- **IN CASE OF A PERMIT EXCHANGE, A REFUND WILL BE ISSUED TOWARDS THE RETURNED PERMIT AND THE PRICE FOR THE NEW PERMIT WILL BE CHARGED TO THE GOLDMINE ACCOUNT. A NEW REGISTRATION FORM WILL BE REQUIRED FOR THE NEW PERMIT.**
- **IT IS ONLY ALLOWED TO PARK IN THE AREA DESIGNATED ON YOUR PARKING PERMIT. NO CROSSPARKING WILL BE ALLOWED IN OTHER HOUSING AREAS.**
- **MINER HOUSING PERMIT HOLDERS ARE ALLOWED TO PURCHASE A SECOND PERMIT AT FULL PRICE, IF PERMITS ARE AVAILABLE.**
- **IF PERMIT IS REPORTED MISSING/LOST AND IS FOUND IN ANOTHER VEHICLE, AN INVESTIGATION WILL BE CONDUCTED AND VEHICLE WILL BE ELIGIBLE TO BE BOOTED WITHOUT PRIOR WARNING.**
